#### 1. Economic Survey : Karnataka's GSDP to grow by 9.5% this fiscal

Karnataka's gross state domestic product (GSDP), which had shrunk for the first time in at least a decade during 2020-21, is estimated to grow by 9. 5% (by over Rs 1-lakh-crore) to Rs 12. 5-lakh crore for 2021-22, the Economic Survey reported.

#### 2. IMF warns Russia-Ukraine conflict escalation would cause 'devastating' economic damage

The International Monetary Fund warned Russia's war with Ukraine and the subsequent sanctions imposed upon President Vladimir Putin's country will have a "severe impact" on the global economy.

"While the situation remains highly fluid and the outlook is subject to extraordinary uncertainty, the economic consequences are already very serious," the Washington-based lender said in a statement.

Indian economy grew by 5.4 per cent in the October-December quarter of 2021-22, official data released showed. The gross domestic product (GDP) had expanded by 0.7 per cent in the corresponding period of 2020-21, according to the data released by the National Statistical Office (NSO).

## 6. GST Council plans to raise 5% tax slab to 8%.

The GST Council in its next meeting might raise the lowest tax slab to 8%, from 5%, according to a report by the PTI news agency, citing sources. A panel of state finance ministers is likely to submit its report by this month end to the Council suggesting various steps to raise revenue, including hiking the lowest slab and rationalising the slab.

## 10. India increasing ethanol storage, targets 20% blended petrol by 2025

India's state-run fuel retailers are increasing their ethanol storage capacity by 51% as the nation targets to double the biofuel's blending with gasoline to 20% by 2025, a director at the country's top refiner Indian Oil Corp. India is the world's third biggest oil importer and relies on foreign suppliers to meet more than 80% of its demand. Prime Minister Narendra Modi has pledged to achieve net-zero carbon emission by 2070, and is encouraging industries to switch to cleaner options including renewable and biofuels to cut carbon footprint.

#### 11. Karnataka readies to exempt GST, royalty on construction material, says CM

Karnataka Chief Minister Basavaraj Bommai has said that he is ready to exempt GST and royalty on steel, cement, and other construction materials if the Centre bears 25% of the land acquisition cost for the projects. CM Bommai was speaking during the foundation laying ceremony for 925 kilometres of the <u>national highway</u>. He said if the Centre agrees to his proposal, a Memorandum of Understanding would be signed in this regard. He also said the state government is ready to offer similar concessions in implementing the Satellite Town Ring Road project in Bengaluru and other cities like Kalaburagi and Belagavi.
